The IYPT version Ecuador has a selection procedure similar to the regulations presented in the IYPT website. We can summarize the procedure adopted in the following stages:

- Online inscription.
- Reception of preliminary report of the registered teams.
- Report evaluation and dissemination of the classified teams.
- Physics Fights with the classified teams according to IYPT international regulations.
- Training of the winner teams
- Ecuadorian team selection
- IYPT tournament, Romania.
