## Terms of Participation

### 1. Declaration of Consent

By signing the confirmation of participation, the undersigned (hereinafter referred to as the participant), who is applying to participate in an event organized by the association International Young Physicists' Tournament (IYPT) (hereinafter referred to as the event), as well as their parents or legal guardian (hereinafter referred to as the legal guardian) agree to the following points.

### 2. Acknowledgement of regulations

The participant acknowledges to have read and understood the IYPT regulations and agrees to adhere to all rules, regulations, guidelines, and decisions of the IYPT.

### 3. Publication and protection of intellectual property

The intellectual property of the solutions and presentations of the participants remain with the participants.

The IYPT reserves the right to collect the presentation of the participants for disciplinary, publicity, and educational purposes. The participants grant IYPT the right to publish works and results as long as the purpose of publication is restricted to promotional purposes of IYPT. IYPT will make every effort to ensure that the author is credited in publications.

The participant respects the intellectual property of other participants. This includes, but is not limited to, not sharing data, solutions, or presentations of other participants with third parties, without the consent of its author.

### 4. Press

The IYPT relies on broad public visibility and media coverage. The participant grants IYPT the right to include their name, place of residence, nationality, and team they compete for in press releases. For interview requests from newspapers, radio, television, or other media, IYPT may share the participants' contact information.

### 5. Pictures, Video and Audio recordings

Photos, video or audio recordings may be made at the event. The participant transfers to IYPT the right to use images, video or audio recordings on official webpages of IYPT, on IYPT's social media pages, in press releases and printed materials of IYPT, as well as in national and international media articles, provided these are related to the event or serve to further the purpose of the association International Young Physicists' Tournament (IYPT) as outlined in its statutes.

## 6. Insurance

The participant and, if applicable, the legal guardian acknowledges that the IYPT cannot guarantee participant supervision during the event. The responsibility of supervision solely rests with the team leaders of the participating country.

The participant is expected to behave appropriately and to follow the organizer's rules, local customs, and laws during the event. Instructions from the organizer must be respected and followed.

## 8. Limitation of Liability

IYPT and its partners exclude contractual liability to the extent permitted by law.

## 9. Applicable law and place of jurisdiction

Swiss law applies and the exclusive place of jurisdiction of all disputes shall be Zurich, Switzerland.
